# REPORT OF THE SELECT COMMITTEE ON WOMEN, YOUTH, CHILDREN AND PEOPLE WITH DISABILITIES COMMITTEE MEETING HELD 17 MAY 2016

# (OFFICE OF THE PREMIER)

#### 1. INTRODUCTION

The Mpumalanga Legislature is duly vested with a mandate to maintain oversight of provincial executive authority and any organ of state and all provincial executive authority including provincial organs of state are accountable to it in compliance with section 114 of the constitution. The legislature is independent and performs its functions impartially without prejudice enshrining the rule of law.

In terms of Standing Rules and Orders of the Mpumalanga Provincial Legislature 2013, the **Select Committee on Women, Youth, Children, and People with Disabilities** (the committee), is established in terms of Rule 135 (h) and has powers to conduct oversight on transversal issues affecting designated groups. The Committee is composed of a multiparty representation and is empowered to develop mechanisms to conduct oversight over provincial departments and public institutions.

The select committee is vested with the power to monitor, investigate and enquire into and make recommendations concerning any organ of state or constitutional body regarding transversal and transformation matters to ensure a province free from gender discrimination and inequalities in promotion of the Bill Of Rights.

The committee in accordance with Rule 119 may summon any person to appear before it to give evidence on oath/ affirmation, or to produce documents and permit oral evidence. The committee may compel an institution or a person to comply with summon subject to the rules and orders or a provincial legislation.

The Legislature seeks to establish whether provincial government delivers services effectively and efficiently within the respective local municipality areas.

## 2. OBJECTIVES OF THE MEETING

The Committee met with the Office of the Premier to assess progress made by the province on issues relating to youth programmes for the 2016/17 financial year and the achievements made for 2015/16 in the following areas of work:

- Youth Economic Empowerment
- Social Cohesion programmes for youth
- Unemployment
- Education and Skills development
- Internship and Learnerships programmes

### 3. METHOD OF WORK

The Committee invited the office of the Premier (Youth Desk) as per the programme of the Legislature and quarterly target of the committee to a committee meeting held on 17 May 2016 and was considered on the 12 August 2016 for adoption.

### 4. PRESENTATION MADE BY OFFICE OF THE PREMIER ON YOUTH ISSUES

The Chief Director Mr. Solly Dlamini presented the delegation to the committee and allowed Mr. Desmond Moela the director of the youth desk in the office of the premier to take the committee through the presentation.

In his presentation, he first outlined the achievements made by departments on the 2015/16 financial year as follows:

## 4.1 ECONOMIC EMPOWERMENT/COOPERATIVES

The committee noted the progress made by department of Economic development and Tourism on the Tyre initiative, supporting 3 outlets owned by youth. The Ntuli Tyres in Nkangala; Skroof Tyres in Ehlanzeni and Mogolo Thapelo Tyres in Nkangala which was reported to be having a shortage of Technical support and equipment in the previous meeting.

Furthermore the committee noted that there are 25 Young people undergoing training on phase 1, 2 and 3 as well as on the job training for the tooling initiative and welcomed the initiative of the department in rolling out the programme to Gert Sibande District in the 2015/16 financial year, and that the roll out to Nkangala will take effect in the 2016/17 financial year.

The Committee also welcomed the employment opportunities created by Department of Human Settlement for 228 young people in the Nkangala District, though the unavailability of budget for stipends still pose a serious challenge as this young people are heading families and stipends can make a difference in their lives.

The matter of 443 young people linked to work opportunities through the 84 Youth Development Centres funded by Department was noted but the challenge was the filling of vacancies left by the youths that got better jobs. It was indicated that the vacancies will be filled in the 3<sup>rd</sup> quarter. The committee wanted a progress in this regards as the previous report about the matter indicated that those vacancies should have been filled already.

#### **BURSARIES AWARDED**

The committee raised a serious concern on the challenges raised by the department of Education stating that most potential youth do not make efforts to apply in institutions of higher learning to pursue their studies and further appealed to all stakeholders to intensify this programme (WHAT PROGRAMME) to schools. The committee further indicated requested that students should be encouraged to apply even if they do not have money, to avoid disappointment when results are in their favour.

#### **EDUCATION ON SUBSTANCE ABUSE**

The committee noted the educational awareness programmes on substance abuse that has already reached 28 institutions without any challenges. The Committee appealed to the department of Social development that the awareness programme must not be a once-off campaign but to continuously educate the young people whose future is being destroyed by substance abuse.

#### 4.2 2016/17 YOUTH DEVELOPMENT PROGRAMMES

The committee welcomed with appreciation the progress made since the establishment of the Youth Desk and further indicated that during this financial year, the implementation plan should be intensified as they presented the following programmes earmarked for the youth for 2016/17 financial year:

The committee welcomed with appreciation the programmes earmarked for the youth for 2016/17 financial year that it is focus driven and noted that under the programme of education and skills development MRTT should play a leading role in training youth in the sector of Artisan skills; as this will allow them to utilize their skills for self-employment in eradicating unemployment.

Furthermore, the initiative of the Youth Desk by including the budget available and the responsible personnel is welcomed by the committee as this will be a good mechanism to ensure that all funds allocated are monitored and spent as budgeted for effective running of the programmes.

#### 4.3.1 FINDINGS

After the deliberations, the Committee made the following findings:

- The department of Education and MRTT on Artisan's Training skills is not taken in to thee recognition as skills for youth to be in market and self employed by initiating their own workshops.
- 2) Department's budgets allocated for youth programmes are diverted to other programmes within departments.
- 3) Department of Education campaigns for awareness with regards to applying for admission to institutions of higher learning and to secure bursaries offered by other departments is still a serious concern.
- 4) Departments that doe provide bursaries not ensuring that learners are aware of the bursaries as coordinated by department of Education.

# 4.3.2 RECOMMENDATIONS

The committee recommend that:

- 1) Departments concerned must encourage youth to take Artisan skills seriously as to other fields of study through MRTT and FET colleges as skilling will play a role in fighting unemployment but also indirectly by providing a stimulus to economic growth and the development of new industries.
- 2) Office of the Premier Youth Desk should monitor that all funds allocated for youth programmes in all departments are utilised effectively and efficiently by monitoring and evaluating the annual performance plan quarterly.
- 3) Department of Education and its stakeholders should strengthen the advocacy campaign in raising awareness for students to apply to institutions of higher learning in time and also take advantage of the bursaries offered by government departments for the benefit of the province in skills based on economy needs.
- 4) All departments must ensure that they play a leading role in ensuring that students do apply bursaries offered and that it must not be department of education role.

# 4 CONCLUSION

The Chairperson extended her appreciation to Members of the Committee, the office of the Premier Youth Desk management team, and the support staff of the Legislature for their participation during deliberations in enhancing the oversight role of the Legislature.

The Committee tables this report to the House for adoption with its recommendations and that the office of the Premier must submit a progress report on a quarterly basis.
